Recovery Help (Ryan):

- No word yet from Sally Petre (TWRA) regarding the stream restoration work in our area. We will talk to Jim Habera (TWRA) next week about this at our chapter meeting.
- Roan Mountain may need some help from us for some stream bank restoration in the community park. Rick will be getting more details for us on this.

Fishing Days and Pint Nights (Evan):

- We had a Blue Line fishing day at Horse Creek on July 19th, seven people attended.
- Future Blue Lines Fishing Days include the following:

- Four chapters have submitted grants for this year.

Rocky Fork Hiker's Jamboree (Evan):

- Had a decent turnout at the event
- The forecast of rain probably scared some people away.
- Sold some raffle tickets and merchandise

Meet the Mountains (Ryan):

- August 15-16
- Volunteer slots for Friday are all filled
- We still need volunteers for Saturday
- Rick and Ryan will be meeting at 5:00PM on Thursday to setup the booth

Brochures / Business Cards in Fly Shops (Ryan):

• Ryan mocked up a brochure and showed it to everyone. We agreed to proceed with the purchase of the brochures.

Hampton Creek (Ryan):

- As related to the FishAmerica grant, J.B. Hill and Lisa walked the fence line below the fish barrier last week and she's waiting on him to send a quote for the job. He said finishing by the December 31st deadline would not be a problem. Lisa will send the quote to us as soon as she receives it. We will have the same arrangement as previously when he fenced the upper part of Area G, he will bill OMTU directly. We will pay for the fencing up front and FishAmerica will reimburse us after we submit the invoices.
- OMTU will conduct a day or two of volunteerism to help clean up fence lines and dispose of
 old fencing. Probably September or October timeframe. Lisa hasn't thought on where the
 project would be best yet, that will require more site visits. Lisa is approaching the county
 for a demolition dumpster.
- TWRA is still waiting for a reply from FEMA on the fish barrier.
- Lisa started refining ideas for the upper cove to install exclusion area fencing to reduce runoff from overuse areas. She feels confident that she's found good by-passes for the cattle to travel.
- With the state park, they have repaired all the OVNHT crossings except the highest one, which will have to be bridged. They've had a contractor there to discuss the project. They have to determine several things and this will take some time to do. If everything goes well, the bridge may be built sometime in 2026. It is passable on foot at low water.
- Lisa has spoken with the NRCS area engineer about re-directing flow in the lower reach of the Left Prong back into the old channel to stop flooding the trailhead area. They have surveyed the stream, but have not produced drawings yet. The area engineer is moving to Vermont and a new staff person is taking over the project. The issue is on their radar. The idea is to re-direct some, but not all of the flow, allowing the new flow to provide water to the flat area of the trailhead to produce wetland vegetation. Once done, an extended boardwalk will be necessary to get hikers to the lower pedestrian bridge.
